Preparation of Learning Material

Quadrant-I: e-Tutorial

Quadrant-II: e-Content

This quadrant comprises Self-Instructional Material (digital SLM), e-books, illustrations, case studies, presentations, and other relevant academic content. It also incorporates curated web resources such as reference links, open-source content, videos, articles, research papers, journals, anecdotal information, and historical developments relating to the subject area.

Quadrant-III: Discussion Forum

This quadrant facilitates continuous academic interaction. Learners can raise queries and receive clarifications in real time from the Course Coordinator or designated academic support team members, thereby strengthening learner engagement and understanding.

Quadrant-IV: Assessment

This includes problems and solutions in various formats such as Multiple-Choice Questions, fill-in-the-blanks, matching items, short and long answer questions, quizzes, assignments and solutions, discussion topics, FAQs, and clarifications on common misconceptions. These assessment components ensure ongoing learner evaluation and formative feedback.

First-year e-learning material in four quadrants for each course is prepared and approved by the statutory authorities of the Higher Educational Institution.

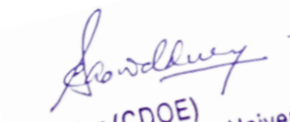
